DSTO OPEN SOURCE LICENSE

Version 1.1, February 2007

Program means the program made available by the Commonwealth of Australia, represented by the Defence Science and Technology Organisation (DSTO) of the Department of Defence, including text, source code, object code and accompanying documentation, if any, stating that it is licensed under this Licence, attaching this Licence or otherwise indicating that it is licensed under this Licence.

Note: the Licence is based on the GPL, but has been amended to accord with DSTO policy requirements.

0. This License applies to the Program. The "Program" refers to the program or work defined above, and a "work based on the Program" means either the Program or any derivative work under copyright law: that is to say, a work containing the Program or a portion of it, either verbatim or with modifications and/or translated into another language. (Hereinafter, translation is included without limitation in the term "modification".) Each licensee is addressed as "you".

Activities other than copying, distribution and modification are not covered by this License; they are outside its scope. The act of running the Program is not restricted, and the output from the Program is covered only if its contents constitute a work based on the Program (independent of having been made by running the Program).

1. You may copy and distribute verbatim copies of the Program as you receive it, in any medium, provided that you conspicuously and appropriately publish on each copy an appropriate copyright notice and disclaimer of warranty; keep intact all the notices that refer to this License and to the absence of any warranty; and give any other recipients of the Program a copy of this License along with the Program.
